Chairman stated Dave Carpenter will be here on March 3rd at 7:30 pm planning commission meeting to discuss lot sizes, frontage, and density. Willard Oschmann – Represented by Wm. Chapman. Mr. Chapman explained Oschmann's plan for condomium building on Ashippun School property. Plans are for 7-4 family buildings or if the school is removed, for 8-4 family buildings. Planning commission must make recommendation first. Chairman Schoenike stated thought should be given to property east of school property. There is a road issue from the west side that should be resolved. Further discussion. Town engineer should look at the plans.

Public input – Syl Hoerth asked if a price for new fire signs was gotten. Sheryl Jaeger stated public hearing on March 15th at 7:00 pm. Mitch Hertneky asked if there would be a public forum for the candidates running for office. Norm Greeb – Agreed there should be something to let people know something about the candidates. Justin Schultz – commented on zoning percentage. If you make an exemption to Mr. Oschmann, are you going to allow exemptions to others? Don Kehl – Are there fire numbers put up in Willow Creek subdivision? Supervisor Rupnow stated he was asked if we should consider the possibility of having a 5-man board compared to a 3-man board.
