The clerk verified that meeting notices were properly given. Roll call was taken with Chairman James Schoenike, Supervisor LeRoy Rupnow, Supervisor Roger Kopfer, and Clerk/Treasurer Evangeline Kuchl as all being present.

The clerk read the February 10, 2005 board meeting minutes. Supervisor Kopfer made a motion to approve the minutes as read, seconded by Supervisor Rupnow. All in favor. Motion carried.

Public Input – Syl Hoerth commented that Mr. Oschmann was here several times and now was told he should be going to the County. Planning commission turned down the Kehl issue. Was anyone from the Board at the County public hearing? Person buying property should make zoning change. Bill Bremer – County is getting 35% of our taxes. Are any meetings held between County and town chairman and supervisors? Willard Oschmann's project should have roads built to Town specs. Is the road in Willow Creek laid out to the lot line? There is a shared driveway on Filmore Road. How and when did that happen?

Treasurer's report was read by Clerk/Treasurer Evangeline Kuehl. Supervisor Rupnow made a motion to accept the report as presented, seconded by Supervisor Kopfer. All in favor. Motion carried.

Presentation of bills was made by Clerk/Treasurer Evangeline Kuehl. Discussion. Supervisor Kopfer made a motion to pay the bills as presented, seconded by Supervisor Rupnow. All in favor. Motion carried.

Police report by Officer Eric Fisher. Busy month for all three areas.

Planning commission minutes read by Clerk/Treasurer Kuehl. Supervisor Kopfer made a motion to accept the minutes as read, seconded by Supervisor Rupnow. All in favor. Motion carried.

Four Winds Subdivision – Dehligha Sebastian was present. Discussion. Wondering if Town would be interested in having a curb at entrance to subdivision, on Roosevelt Road. Electric Company to take care of street lights. Sebastian's will pay the cost.

Don Christopherson read Building Inspector's report for February.

Road report made by Clerk Kuehl and Chairman Schoenike, in the absence of Larry Krier. Men are busy keeping roads in driving condition and fixing equipment.

Brian Shanklin – Discussion. Town concerned about outside conditions. Should keep things cleaned up. Mr. Shanklin asked who to see about putting up a two-car garage.

Adoption of Code of Ordinances – Land Division ordinance is not included in the ordinances. Will be done later this year. Discussion. Supervisor Rupnow made a motion to adopt the new code of ordinances, seconded by Supervisor Kopfer. All in favor. Motion carried.

Correspondence – Clerk/Treasurer Kuehl stated there are some delinquent personal property taxes for this year. What can be done to collect the money? Chairman Schoenike will make personal visit to the people.

Public Input – Bill Bremer asked how long tapes, from the meetings, must be kept? He wants copies from January, February, and March meetings. Also from future meetings.

Supervisor Kopfer made a motion to adjourn the meeting, seconded by Supervisor Rupnow. All in favor. Motion carried. 7:40 p.m.
